- Completed tender documents in sealed envelopes should be deposited in the Ng-Cdf Kipipiri Office tender boxes at Miharati (placed at the office entrance); **by 4<sup>th</sup> November 2021 at 11:00am** where the opening exercise will take place immediately.
- **NB;** - any contractor with an abandoned/stalled **Ng-Cdf** project need not apply.
  - Tender opening, evaluation and awards will be centralized at the designated stations, to ensure that there is full involvement of the public works officer and supply chain management officers in the process and that no contractor takes more than three projects at any given time.
  - The bids must be registered in tender/quotation register of the procuring entity (head teacher, principal, other head of departments'/ institutions)
  - All tender documents must be properly addressed to respective institutions' secretaries and must have tender numbers.
  - All tender envelopes must be properly sealed and signed by the bidders
  - Tender documents from the **PMCS**, shall **NOT** be denied to any interested prequalified contractor if the closing date and time has not elapsed.
