Special Groups are encouraged to competitively apply for reserved tenders as long as they meet the required qualifications. The Special Groups are for Youth, Women and Persons with Disability and must attach **valid** copy of registration certificate from National Treasury.

Tender responsiveness minimum criteria will be based on the following requirements.

- (a) Copy of Business Registration/Incorporation;
- (b) Copy of KRA PIN Registration Certificate;
- (c) Copy of current and valid Tax Compliance Certificate;
- (d) Copy of CR 12
- (e) Copy of Valid Registration Certificate with National Construction Authority Building Works Contractor and Valid Contractor Annual Practicing Licenses for specific categories as indicated in the above table.
- (f) Duly filled Form of Tender
- (g) Duly filled Confidential Business Questionnaire
- (h) Must provide a Bid Bond of 1% of the bid price **Not Including** Youth, Women and Persons living with disability who should provide a copy of Access to Government Procurement Opportunities Certificate.

In addition, interested bidders must show proof of the following;

- a) Proof of adequate Equipment and Key Personnel.
- b) Proof of works of similar magnitude.
- c) Evidence of sound financial standing and access to bank credit line.
- d) A copy of payment receipt.

Failure to meet these requirements will render the bid non responsive in the minimum qualification criteria category and hence no further evaluation on such a bid will be undertaken.

Further, bids from the following shall be automatically non-responsive and disqualified:

- (a) A bid from a tenderer whose on-going works are behind schedule without approved time extension;
- (b) A bid from a tenderer whose on-going works have been served a default notice;
