- v. Valid Single Business Permit
- vi. Submit a 300,000.00 Bid Bond of total price from a recognized Bank or Authorized Insurance firm by the PPRA.
- vii. Details and evidence of experience in works of a similar nature and size for each of the last three years giving certificates of practical completion and details of clients who may be contacted for further information.

- ix. Provide proof of major items of construction equipment to carry out the proposed works.
