- Attach Certified Copies of Audited Financial Report from a reputable firm for the last three years;
- Provide a Bid Security equivalent to 2% of bid price from AUTHORIZED institutions. (*Bidders who had previously submitted their bids are exempted from this requirement*)
- Attach Certified Copies of CR12 with copies of Director's ID;
