a) Requirements for Appointment

For appointment to this position, a candidate must have:

- i. Bachelor's degree in any of the following disciplines: - Economics, Project Planning and Management, Statistics, or equivalent qualification from a recognized institution;
- ii. Proficiency in computer applications; and
- iii. Satisfy the requirements of Chapter 6 of the Constitution of Kenya.

(b) Duties and Responsibilities:

The Planning Officer will report to the Chief Manager, Corporate Planning and Strategy through the Principal Planning Officer and will be responsible for the following:

- i. Draft work plans and budgets;
- ii. Assist in the preparation of monthly, quarterly and annual reports;
- iii. Draft performance contracts for the Board and NG-CDF Committees;
- iv. Assist in formulation of the strategic plan in consultation with key stakeholders to facilitate effective realisation of the organisation's mandate;
- v. Assist in undertaking annual review of the strategic plan in view of changes in the operational environment;
- vi. Provide support in formulation and review of various policy documents;
- vii. Assist in monitoring and evaluation of Board interventions.
- viii. Any other duty as may be assigned by the supervisor.
