Pursuant to the provisions of the National Government Constituencies Development Fund (NG-CDF) Act 2015 (amended 2016) in sections 43(1), (2), (3) and 57(1) and its regulations, Ainamoi Constituency invites Members of the general public to submit written applications for Membership to the National Government Constituency Development Fund Committee of Ainamoi Constituency under the following **categories**:

1. Adult Male Representative – 1 position – AINNG-CDF/001
2. Youth Male Representative – 1 position – AINNG-CDF/002
3. Adult Female Representative – 1 position – AINNG-CDF/003
4. Youth Female Representative – 1 position – AINNG-CDF/004
5. Person Living with Disability – 1 position – AINNG-CDF/005



Applicants should have the following qualifications: -

1. Be a citizen of Kenya;
2. Ordinarily a resident voter in the constituency;
3. Be able to read and write, and to communicate in English and Kiswahili;
4. Meet the requirement of Chapter six of the Constitution of Kenya;
5. Is available to participate in activities of a constituency committee;
6. For the youth nominee, he/she must have attained the age of eighteen years but be below the age of thirty-five years
7. Person living with disability (PWD) representatives should be endorsed by a registered group for PWD within the constituency through a minute resolution.

Interested applicants are required to submit their hard copy applications in writing to **Ainamoi NG-CDF Office at DCC HQs Kericho room 3 or 19** attaching certified copies of testimonials for the above requirements clearly indicating the position applied for, the home ward, copy of identity card and voter's card, day time telephone, postal and e-mail addresses as to reach the undersigned on or **21st October 2022 at 5:00 pm.**
