- a) Copy of Business Registration/Incorporation;
- b) Copy of KRA PIN Registration Certificate;
- c) Copy of current and valid Tax Compliance Certificate;
- d) Copy of CR 12
- e) Copy of Valid Registration Certificate with National Construction Authority Building Works Contractor and Valid Contractor Annual Practicing Licenses **NCA 8 and Above (Building Works Contractor)**.
- f) Duly filled Form of Tender
- g) Duly filled Confidential Business Questionnaire
- h) Self-declaration that the person / tenderer is not debarred in the matter of the Public Procurement and Asset Disposal Act 2015.
- i) Self-declaration that the person / tenderer will not engage in any corrupt or fraudulent practice.
- j) Declaration and commitment to the Code of Ethics.
- k) Must provide a Bid Bond of 1% of the bid price **Not Including** Youth, Women and Persons living with disability who should provide a copy of Access to Government Procurement Opportunities Certificate.
- l) The Tenderer shall chronologically serialize all pages of the tender documents submitted.
- m) The Original Tender shall be typed or written in indelible ink and shall be signed by a person duly authorized to sign on behalf of the tenderer.
- n) Proof of adequate Equipment and Key Personnel.
- o) Proof of works of similar Nature, complexity or magnitude.
- p) Evidence of sound financial standing and access to bank credit line

Failure to meet these requirements will render the bid non responsive in the minimum qualification criteria category and hence no further evaluation on such a bid will be undertaken.
