### INSTRUCTIONS TO TENDERERS:

#### 1. MANDATORY REQUIREMENTS

Eligible bidders must meet and attach the following mandatory requirements among others: -

- b) Confidential business questionnaire - Correctly filled, signed and stamped.
- c) Certified copy of certificate of incorporation /business registration certificate
- a) **Valid** Registration Certificate with National Construction Authority (NCA) – Construction and Building works category (**NCA 6 and above**)
- b) **Valid and Up to date** Practicing License with National Construction Authority category (NCA 6 and above)
- c) **Valid and Up to date** Single Business permit
- d) **Valid and Up to date** Tax Compliance certificate.
- e) Certified copy of current CR12 certificate (within this Financial Year).
- f) Certified copies of national identity card/passport for the company directors.
- g) Must attach the most recent bank statement to proof your financial capacity (last three months)
- h) Bidders **MUST** serialize all the pages of their tender documents.
- i) Prices quoted must remain valid for **One Hundred and Fifty (150 days)** from the date of tender opening.
- j) Litigation history (it must be current within one (1) year from the date of submission of the tender

- k) Bidder must provide all the information required as per the advertisement and tender document
- l) Provide a brief work methodology
