- 11) Evidence of similar works for the last 3 years for open category.
- 12) Proof of financial Soundness
- 13) Litigation History (both court and arbitration).
- 14) All pages of the bid documents must be Tape bound, signed, paginated and stamped. The table of contents should also be provided and the document accordingly arranged
- 15) Signed and stamped statement of verification that not debarred in matters of public procurement proceedings (Must be from the commissioner for oaths).
