INSTRUCTIONS TO CANDIDATES**

Invitation for Pre-qualification

1. The NG-CDF Imenti Central intends to pre-qualify suppliers/contractors for goods and services for the period ending June 30th 2027 as part of updating the register of suppliers.
2. Pre-qualification is open for all eligible suppliers and contractors who are registered with National Construction Authority (NCA). However preference and reservations regulations apply in certain categories that will be determined by the NG-CDF Imenti Central.
3. Eligible candidates are requested to strictly adhere to submission procedures as outlined in the advertisement whose copy is copied below.
4. All candidates whose applications will have been received before the closing date and time will be advised in due course, of the results of their application. Only candidates qualified under this Pre-qualification process will be invited to tender.
5. All the information for Pre-qualification shall be provided in the English language.
6. Failure to provide information that is essential for effective evaluation of the applicant's qualifications or to provide timely clarification may result in the applicant's disqualification.
7. In assessing suitability, the eligibility criteria set out below will be used.
8. The applicant shall not be associated or related with employees of NG-CDF Imenti Central.
9. As required by law or such associates should be declared as provided for in the Public Procurement law and regulations.
10. Pre-qualification will be based on meeting the minimum requirements to pass in the criteria outlined below.
